

**NOTICE OF PROPERTY TAX DELINQUENCY
AND IMPENDING DEFAULT**

Made pursuant to Section 3351 – 3353 & 3436 – 3437, Revenue & Taxation Code

I, Karen Vogel, Imperial County Tax Collector, State of California, certify as follows:

That at close of business on June 30, 2022, by operation of law, any real property (unless previously tax-defaulted and not redeemed) that has any delinquent taxes, assessments, or other charges levied for the fiscal year 2021- 2022, and/or any delinquent supplemental taxes levied for any year prior to the fiscal year 2021-2022 , shall be declared tax-defaulted.

That a detailed list of all properties tax-defaulted as of June 30, 2022, and not redeemed prior to being submitted for publication, shall be published on or before September 8, 2025.


Real property remaining in tax-defaulted status for five or more years will become subject to the tax collector's power to sell. Once subject to the power to sell, real property may be sold at public auction or otherwise conveyed to new ownership.

The owner may avoid the power to sell status by initiating and maintaining an installment plan of redemption, on eligible parcels, prior to the date when the tax collector obtains the power to sell the property; or by completely redeeming the property through payment of all unpaid amounts, together with penalties and fees prescribed by law, before 5 p.m. on the last business day before the actual sale of the property by the tax collector.

**NOTICE OF IMPENDING POWER TO SELL
TAX-DEFAULTED PROPERTY**

Made pursuant to Section 3361 – 3364 & 3381, Revenue and Taxation Code

Pursuant to Revenue and Taxation Codes sections 3691 and 3692.4, the following conditions will, by operation of law, subject real property to the tax collector’s power to sell.

- 1) All property for which property taxes and assessments have been in default for five or more years.
- 2) All property that has a nuisance abatement lien recorded against it and for which property taxes and assessments have been in default for three or more years.
- 3) Any property that has been identified and requested for purchase by a city, county, city and county, or nonprofit organization to serve the public benefit by providing housing or services directly related to low income persons and for which property taxes and assessments have been in default for three or more years.

The parcels listed herein meet one or more of the criteria listed above and thus, will become subject to the tax collector’s power to sell on July 1, 2022, at 12:01 a.m., by operation of law. The tax collector’s power to sell will arise unless the property is either redeemed or made subject to an installment plan of redemption initiated as provided by law prior to 5 p.m. on June 30, 2022. The right to an installment plan terminates on June 30, 2022, and after that date the entire balance due must be paid in full to prevent sale of the property at public auction.

The right of redemption survives the property becoming subject to the power to sell, but it terminates at 5 p.m. on the last business day before actual sale of the property by the tax collector. Should the property be sold for nonpayment of taxes, the right of redemption will terminate.

The amount to redeem, in dollars and cents, is set forth opposite its parcel number. This amount includes all defaulted taxes, penalties, and fees that have accrued from the date of tax-default to June 30, 2022.
