

**NOTICE OF PUBLIC INTERNET AUCTION
OF TAX-DEFAULTED PROPERTY FOR DELINQUENT TAXES
BEGINS FEBRUARY 9, 2024 & ENDS FEBRUARY 12, 2024
Made pursuant to Section 3702, Revenue and Taxation Code**

On November 1, 2023, I, Suzanne C. Bermudez, Imperial County Treasurer-Tax Collector, was directed by the Board of Supervisors of Imperial County, California, to conduct a public auction sale. The tax-defaulted properties listed below are subject to the tax collector's power of sale.

The sale will be held online at www.bid4assets.com beginning at 8:00 a.m. PT (11:00 a.m. ET) on Friday, February 9, 2024 to February 12, 2024, as a public auction to the highest bidder for not less than the minimum bid as shown on this notice. Computer workstations are available to the public at most public libraries. Instructions for submitting bids are available at www.bid4assets.com. Research the item prior to bidding. Due diligence research is incumbent on the bidder. The winning bidder is legally obligated to purchase the item.

Also, pursuant to specific statutes, should circumstances arise that would warrant the following action(s), the Treasurer-Tax Collector has the authority to do the following:

- 1) Postpone the sale, or any portion thereof, to a new time, date and place, by public declaration at the time and place originally fixed for the public auction. No other notice of the postponed public auction need be given if the new time and date is within (7) seven days of the time originally fixed for the sale. *R&T Code 3706.1(a)*;
- 2) Postpone the sale, or any portion thereof, to a new time, date and place to be held not less than (8) eight nor more than (90) ninety days from the date and time originally fixed for the sale, by public declaration at the time and place originally fixed for the public auction, providing that the requirements set forth in R&T Code 4675 are met. *R&T Code 3706.1(b)*. Should such a postponement be announced to follow this auction, the commencing date shall be April 12, 2024 at 8:00 a.m. PT (11:00 a.m. ET) and continuing from day to day thereafter as necessary.
- 3) Re-offer any unsold parcel(s) at the same or next scheduled sale at a reduced minimum price deemed appropriate in light of the most current assessed valuation of that property or those interests, or any unique circumstance with respect to that property or those interests. *R&T Code 3698.7(c)*. Any parcel remaining unsold may be re-offered within a 90-day period and any new parties of interest shall be notified in accordance with R&T Code 3701.

Pre-registration is required. Register on-line at www.bid4assets.com by Monday, February 5, 2024 (1:00 p.m. PT/4:00 p.m. ET). Bidders must submit a refundable deposit of \$2,500.00 to Bid4Assets. Refer to their website for details www.bid4assets.com. The deposit will be applied to the successful bidder's purchase price. Full payment and deed information indicating how title should be vested is required within 48 hours after the end of the sale. Only Certified Funds/Cashier's Check/Bank Money Orders and Wire Transfer payments will be accepted. A California transfer tax will be added and collected with the purchase price and is calculated at \$.55 per each \$500 or fraction thereof.

All property is sold as is. The county and its employees are not liable for the failure of any electronic equipment that may prevent a person from participating during the sale.

The right of redemption will cease on Thursday, February 8, 2024, at 5:00 p.m. and properties not redeemed will be offered for sale. If not sold, the right of redemption will revive until the close of business on the last business day prior to the next scheduled sale. Redemptions must be received in cash, cashier's check or money order.

If the properties are sold, parties of interest, as defined in California Revenue and Taxation Code Section 4675, have a right to file a claim with the county for any excess proceeds from the sale. Excess proceeds are equivalent to the amount of funds remaining after liens and cost of the sale is paid. Notice will be given to any parties of interest on record, pursuant to law, where the excess amount is greater than or equal to \$150.00.
