The declaration of default was due to non-payment of the total amount due for the taxes, assessments and other charges levied in fiscal year 2020-2021 that were a lien on the listed real property. **The name of the assessee and the total which is due during the month of September 2024 is shown opposite the parcel number.** Tax-defaulted real property may be redeemed by payment of all unpaid taxes and assessments, together with the additional penalties and fees, as prescribed by law, or it may be redeemed under an installment plan of redemption (if not already under an active plan). If the taxes remain unpaid after July 1, 2026, the property will be subject to sale at public auction. 
