The declaration of default was due to non-payment of the total amount due for the taxes, assessments and other charges levied in fiscal year 2022-2023 that were a lien on the listed real property. **The amount to redeem, including all penalties and fees, as of September 2026 is shown opposite the parcel number and next to the name of the assessee.** Tax-defaulted real property may be redeemed by payment of all unpaid taxes and assessments, together with the additional penalties and fees, as prescribed by law, or it may be redeemed under an installment plan of redemption (if not already under an active plan). If the taxes remain unpaid after July 1, 2027, the property will be subject to sale at public auction. 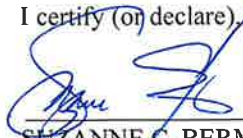
